As a member of the Greater Gainesville Dog Fanciers' Association, Inc., I promise to uphold the Club's Code of Ethics and By-Laws and pledge the following:

- a) to comply with all AKC rules and regulations and to breed only dogs which are purebred and of the same breed.
- b) to maintain high standards in the care, breeding, and maintaining of the Breed.
- c) to breed only those dogs which are representative of the Standard of the Breed.
- d) to refuse to sell any dog which does not meet the Breed Standards for breeding purposes, or to sell it as a pet, only if the dog is neutered, spayed, or if the bill of sale notes that the dogs will be on a limited registration.
- e) to refuse to supply dogs for any commercial enterprise.
- f) to give an honest representation of the dogs and puppies offered for sale, without intent to mislead or advertise falsely in any way.
- g) to provide with any dog sold, a complete health record, registration record, (as applicable) pedigree, diet, and care information and to continue to provide reasonable help for the life of the dog.
- h) to share with the public my knowledge of the Standard and care of my Breed.
- i) to conduct myself in such a manner as to promote good sportsmanship, never demeaning another fancier or his breed, nor compromise the integrity of this Club.
