Vehicle Parking will be done by the Greater Gainesville Dog Fanciers' Association, Inc. Any vehicle blocking a Fire Lane or another vehicle from entering/exiting WILL BE TOWED AT OWNER'S EXPENSE.

We expect everyone to observe the ethical practice of good housekeeping and reserve the right to ask anyone who does not conform to these standards to leave. There will be plenty of trash cans at the show site. Fire lanes must remain open at all times.

No golf carts or bikes (electric or otherwise) are permitted in the showing areas at any time.

Generators will not be allowed without proper mufflers. No generators allowed within 50 feet of the Obedience & Rally Rings.

**Dogs entered** in these events MUST have an up-to-date rabies vaccination and record thereof available. **No unentered puppies** or dogs allowed at ringside.

Inappropriate attire will not be tolerated; please wear appropriate clothing that will not hinder or detract from the presentation of your dog.

All persons attending these dog events hereby waive any claim for damages against the Greater Gainesville Dog Fanciers' Association, Inc. or the Lake Eustis Kennel Club, Inc. or either club's members.


All hotels/motels listed in this premium list as accepting dogs are considered to be part of the event site. Most major chains are located in the Ocala Metro Area.

# DIRECTIONS TO THE EVENT SITE

**From I-75:** Exit 358, State Rd. 326, go East approximately 1 mile to traffic light, turn left onto 25A, go North approximately 2.4 miles. Show Grounds on right with Greater Ocala Dog Club sign.

From the East: Westbound on FL-Rt. 40, turn right on E. Highway 326 (Ocala Bypass traffic light). Continue on 326 West for 10.4 miles. At N.W. Gainesville Road (25A traffic light), turn right. Show Grounds are 2.4 miles on the right.



## **CLASSIC RV PARKING GUIDELINES & INFORMATION**

The January Gator Classic 2025 will be located at the greater Ocala Dog Club Show Grounds, just two and a half miles off of I- 75 in Ocala, Florida.

Our sites are approximately 30' x 50' and include electric. If your unit is longer than 50' you will need to either purchase two sites or find a friend that has a smaller unit and is willing to share their spot with you. You must send these in together and explain you need an end-to-end spot so you can share.

Additional overnight RV Parking is available without electricity for \$20.00 per night. If you need to drop your trailer after you unload to a different area so you will fit, we will provide you with one at no additional charge.

If your tow car doesn't fit into your space, please move it to day parking. If you tow a car onto the show grounds, you will receive a tow pass so you can come and go with no additional charge. If not, you can purchase a pass at the gate from the individual clubs. Please ask your clients to park in the day parking and not in front of your RV.

We need to keep our fire lanes clear at all times thank you. Water is available at the end of each row. Our water is just for fill and not for continuous hook up. This is a county rule and must be followed. You will need to bring extra hose with you and share with your neighbors to reach.

Also bring extra electric cords with you as you are not always close to your outlets. There are no Pump Out facilities on the show grounds, Pump Outs will be available, cash only see driver for cost.

The Greater Ocala Dog Club Inc. reserves the right to assign all parking. All campers are asked to observe quiet hours in the evenings. A camping unit includes one motor home and a vehicle in tow or a tow vehicle and trailer.

Deadline for RV Parking is January 9, 2025. No reservations will be accepted after that date. This doesn't mean I have no electric sites available, just you will have to show up and see.

No checks accepted after the closing date so you will have to bring cash.

The following breeds must be judged on a Ramp through all levels of conformation competition: Lagotti Romagnoli, Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

## ATTENTION OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1.

Most important to note are the following:

- 1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
- 2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, *regardless of whether the dog earned any points or awards*. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at: http://images. akc.org/pdf/extenap.pdf

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. #### INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

- Telegraph, Telephone (Except Dial-N-Entry<sup>®</sup>) and Unsigned Entries Cannot Be Accepted. Entries Not On Official AKC Entry Forms, Downloaded and/or Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.
- Mail All Entries With Fees to MB-F, Inc., Superintendent, P.O. Box 22107, Greensboro, NC 27420. Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practicable with tickets and/or identification cards. The person accompanying a dog must show tickets of admission and identification before the dog will be received. Should such acknowledgement not be received by the exhibitor within a reasonable time, please verify your entry with the MB-F Office in North Carolina.

Entries must be accompanied by a cover sheet stating the number of pages, what shows and how many dogs per show. Visa/Mastercard/Discover/American Express number and expiration date, as well as the printed cardholder's name and address must be included on cover sheet. Visa/ Mastercard/Discover/American Express number, expiration date and cardholder's name must appear on each entry. Fax entries must be received by the closing hour/date. Fax fee: \$4.95 per entry in addition to entry fee. All credit card entries, regardless of method submitted, are processed through the Fax program and are charged the \$4.95 administrative fee. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.50 each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show. All Recording and Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show. All Recording and Event Service Fee sare paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.) No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.
- Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management, it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent's Office advised at once. The Superintendent and Show-Giving Club disclaim any liability for cash prizes after the judging of the breed is over.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.
